Rules of Organization and Procedure

for the 2021 North/West Lower Michigan Synod Assembly

The Synod Council recommends adoption of the following Rules of Organization and Procedure for the 2021 North/West Lower Michigan Synod Assembly:

General Elections / Voting

- A. The 2021 Synod Assembly will take place using Zoom technology. Participants will access the meeting via a link which will be provided prior to the start of the meeting using their personal smartphone, Tablet, or computer.
- B. All elections will be by ballot vote as per \$9.08.
 - [Synod Constitution Reference S9.08.: "In all elections, except for the bishop, the names of the persons receiving the highest number of legal votes, but not elected by a majority of the legal votes cast on a preceding ballot, shall be entered on the next ballot to the number of two for each vacancy unfilled. On any ballot, when only two names appear, a majority of the legal votes cast shall be necessary for election."]
- C. All voting shall be by electronic ballot using VeVox technology (once credentials are established). Voting members will access their ballots via a URL address which will be provided prior to the meeting for use on a personal smartphone, Tablet, or computer. It is recommended that the device used for voting is different than the device used to access the Zoom meeting.
- D. Technology and voting orientation sessions will take place by Zoom prior to the assembly to allow time for voting members to learn about how to attend, participate in, and vote during the Synod Assembly.

Debate

E. Debate is limited to two minutes per speaker. All speakers shall identify themselves by name and congregation/ministry/retired, etc.

Voice & Voting Privileges

F. Permission is granted for rostered pastors of full communion partner churches, serving ELCA ministries under contract in this Synod, full voice and vote in all Synod Assembly proceedings as per \$7.27.

[Synod Constitution Reference – S7.27.: "This synod may establish processes through the Synod Council to grant a minister of Word and Sacrament from a church body with which a relationship of full communion has been declared and established by the Churchwide Assembly of the Evangelical Lutheran Church in America the privilege of both voice and vote in the Synod Assembly during the period of that minister's service in a congregation of this church."]

- G. Permission is granted for up to two lay persons, one male, one female, from our Synodically Authorized Worshipping Community (The Christ Sudanese Congregation, Wyoming) to have full voice and vote in all Synod Assembly proceedings as per S7.26.
 - [Synod Constitution Reference S7.26.: "This synod may establish processes through the Synod Council that permit representatives of congregations under development and authorized worshiping communities of the synod, which have been authorized under ELCA bylaw 10.02.03., to serve as voting members of the Synod Assembly, consistent with *S7.21."]
- H. Permission is granted for the Synod Attorney to have voice but not vote at the Synod Assembly to support proceedings and to provide clarification as needed relative to the governing documents and policies of the synod as requested by the Synod Assembly Chair, the Synod Bishop or Synod Vice President as per S7.23.

[Synod Constitution Reference – S7.23.: "The presiding bishop of the Evangelical Lutheran Church in America and such other official representatives of this church as may be designated from time to time by the Church Council shall have voice but not vote in the meetings of the Synod Assembly. Like privileges shall be accorded to those additional persons whom the Synod Assembly or the Synod Council shall from time to time designate."]

Budget & Resolutions

- I. Pre-Assembly Discussion Sessions will take place by Zoom prior to the assembly to allow time for review of budget information and proposed resolutions followed by discussion and questions.
- J. As per S11.01.A21, all resolutions for consideration during the Synod Assembly were required to be submitted to the chair of the Resolutions Committee by April 7, 2021 for inclusion in the pre-Assembly packet. There will be no resolutions submitted during the 2021 Synod Assembly.
 - [Synod Constitution Reference S11.01.A21: "Due to the assembly restrictions imposed by the Covid-19 pandemic, protocols for the presentation and consideration of resolutions and churchwide memorials presented to the Resolutions Committee for the 2021 Synod Assembly only are:
 - 1. All resolutions and churchwide memorials shall be submitted to the chair of the Resolutions Committee by April 7, 2021.
 - 2. All resolutions and churchwide memorials shall be included in the pre-Assembly packet. No additional resolutions or churchwide memorials will be considered during the 2021 Synod Assembly.
 - Prior to the 2021 Synod Assembly, ZOOM meetings shall be scheduled during which resolutions and churchwide memorials, correctly submitted for consideration by the 2021 Synod Assembly, will be discussed."]
- K. Resolutions submitted in advance of the synod assembly by the stated deadline must be supported by at least 25 Confirmed members of the synod as per S7.33.A19.
 - [Synod Constitution Reference S7.33.A19: "Resolutions presented to the Reference and Resolution Committee for referral to the Synod Assembly for action shall be supported by at least 25 Confirmed members of the North/West Lower Michigan Synod whose signatures appear on the resolutions as submitted."]



Report of the Bishop North/West Lower Michigan Synod ELCA



2021 Synod Assembly

God's promise in Deuteronomy 30:4 is absolute. Even if we are exiled to the ends of the world, God will gather us and bring us back. God declares an event that will assuredly take place. God's promise evokes Isaiah's vision of the mountain where the Lord of hosts will prepare for all peoples a feast of rich food and well-aged wine and will swallow up death forever (Isaiah 25:6-9). Perhaps we remember Revelation's vision (21:24-27) of the new Jerusalem, a city with gates that are never shut into which all the glory and honor of the nations are brought. And as we gather virtually just before the Seventh Sunday of Easter, we recall Jesus' promise, "And I, when I am lifted up from the earth, will draw all people to myself" (John 12:32). We give thanks Jesus has gathered us and all creation even from death, we participate in the way Jesus is gathering the most vulnerable to himself in this life, and, with patient and confident hope, we wait for the day when Jesus will gather us again as congregations and Synod.

As part of preparing this report, I reviewed my report to the 2019 assembly. It contains information that continues to be pertinent today. Rather than repeating that information here, I invite you to revisit my report to the 2019 assembly. In retrospect, it is obvious to me that I attempted to pass on my best wisdom in the event that report turned out to be my "farewell address." This year, I hope a relatively brief assembly invites a relatively brief written report.

It is now an established fact that, in actuality, this Report of the Bishop is an anthology. I thank my collaborators in the writing and editing of this report—Pastors Rosanne Anderson, and David Sprang, Ms. Chelsey Satterlee, Vice President Sandy Schlesinger, and Ms. Ann Stavros—for their review and contributions. I also thank this report's editors, Ms. Renee Dixon and Ms. Chelsey Satterlee, and the pre-assembly book's editor, Ms. Rebecca Bossenbroek.

ASSEMBLY QUICK Q&A

Q: Why are we having an assembly?

A: We are holding 28 elections: Synod Council, Consultation Committee, Discipline Committee, and voting members to the 2022 ELCA Churchwide Assembly. The ELCA constitution requires that voting members to a Churchwide Assembly be elected by a Synod Assembly.

Q: Why are we having a virtual assembly?

A: It is not yet time for us to gather together in person. As I write this on April 3, 2021, the Michigan State Health Department reported 8,413 new COVID-19 cases, which is the highest daily case count Michigan has reported since December 2020. Health experts are expecting the number of cases to continue to rise in the coming weeks and so we are prioritizing the health and safety of our voting members by meeting virtually.

Q: Why are we having a "business only" assembly?

A: The assembly is limited to six hours, which is a long time to sit in front of a computer on Zoom. To meet this timeframe, we will receive reports, hold elections, consider resolutions, and vote on a budget. Pre-assembly discussion sessions provide opportunity for discussion on the budget and resolutions.

Q: Why is there a charge for the assembly?

A: The registration fee is set to cover the costs of the assembly, including production assistance and voting software.

Q: Where can I find information about this assembly?

A: All relevant information about our Synod Assembly, including important documents and Tech Help Desk information can be found on the Assembly page of the Synod website: https://mittensynod.org/events/assembly

Q: Who is our ELCA Churchwide representative?

A: I am delighted to welcome to our assembly **Ms. Jodi Slattery**, who serves as Executive for Governance at the ELCA Churchwide Organization. Ms. Slattery has come to know the North/West Lower Michigan Synod through her leadership of the ELCA COVID-19 Grant Program. In partnership with the ELCA Churchwide Organization, our Synod distributed \$55,000 through 24 congregations to provide food and shelter throughout the pandemic. Pastor David Sprang estimates that this grant program directly touches the lives of 2100 Michiganders each week.

Q: Will there be a Synod Assembly offering?

A: Since our assembly will not include a worship service, and therefore no designated offering, we offer a few giving suggestions for congregations who desire to make a contribution in lieu of the traditional Synod Assembly offering:

Living Stones Initiative - This giving campaign was announced to the 2019 Synod Assembly as a means for those committed to, and appreciative of, synodical ministry to support the Synod's operational budget in fiscal years ending 1/31/21, 1/31/22 and 1/31/23. Just as some give directly to Living Water Ministries, Samaritas, etc., Living Stones is a way to give directly to the North/West Lower Michigan Synod.

Seminary Debt Reduction Fund - This fund provides \$2,000 grants to pastors and deacons within their first 15 years of ministry who are carrying student loan debt after seminary graduation. We were able to assist three of six applicants with the gifts received during 2020.

Synod Disaster Relief Fund - This fund was instrumental in providing assistance to those affected by the flooding in the Midland area last year. It is the fund through which COVID-19 grants from churchwide are channeled to provide assistance to congregations engaging with their communities to assist those most affected by the pandemic.

We extend heartfelt thanks to congregations and individuals who have already contributed to these ministries, many of whom continue to do so on a monthly basis. Your faithful generosity is crucial to the ministry we do together to make a difference in the lives of others for the sake of Christ.

VISION

"Proclaiming Christ and Prayerfully Participating in Jesus' own work of reconciling the world to God's very Self by Renewing Congregations, Empowering Leaders, and Strengthening Connections." This vision provides the "template" for all my reports. It also directs my ministry and the work of the Synod Staff. We desire that everything we do proclaims Christ, is bathed in prayer, is part of Jesus' work of reconciliation, and that we can draw a direct line from whatever we are doing to either renewing congregations, empowering leaders, or strengthening connections.

PROCLAIMING CHRIST

Pastors Rosanne Anderson, David Sprang, and I take turns providing a recorded sermon, which is made available to congregations in our Synod. Our intention is to give pastors a respite and to continue to connect with congregations as we proclaim the gospel of Jesus Christ. Currently, 50 congregations have registered to receive the video sermons each week.

The Synod has also produced complete services for congregational use, including daily sermons for Holy Week 2020, an Easter Vigil, Pentecost Hymn Sing, All Saints' Day Prayer Service, Christmas Lessons and Carols, and a service for the Second Sunday of Easter. We are grateful for the choirs and musicians in congregations who partnered with us on these services and for the video production and editing done by Ms. Chelsey Satterlee, Director of Communications.

When I became bishop in 2013, I was told of the Synod's desire that the bishop (and assistants) be in congregations on Sundays. We take this desire very seriously and have missed being among you. All three of us name preaching as the most important and life-giving part of our work. As we move toward returning to outdoor worship later this summer and, hopefully, in-person worship in the fall, we look for guidance as to whether our being in congregations each week continues to be a priority. In terms of returning to in-person worship during this pandemic, I remain the most conservative pastor in our Synod because I am aware that what Pastor David, Pastor Roseanne, and I do sets expectations for others.

RENEWING CONGREGATIONS

Call Process: When I wrote this report for the 2019 Synod Assembly, 11 congregations were engaged in the call process. In the intervening two years, we achieved a period of time during which no congregation was seeking a pastor. Currently, one congregation is seeking a part-time pastor and a handful of pastors are interested in a change of call to targeted locations within the Synod. I expect this stability to end with the conclusion of the pandemic. Conflict between some of our pastors and their congregations developed during the pandemic and in some cases, long-smoldering disagreements reignited. After pastors and parishioners have experienced each other vulnerable and not at their best, there may not be a way for the pastoral relationship to regain equilibrium. I expect both rostered ministers and congregations to address conflicts and concerns appropriately before entering into a call process.

Matching the best pastor or deacon with the right congregation is key to renewing congregations. We therefore seek a call process that is thoughtful, prayerful, transparent, and deliberate. You can read the call process manual here. We will continue to meet with call committees via Zoom because this allows us to be a consistent partner. I am profoundly grateful to retired pastors who serve as interim and stated supply, giving congregations the time that they need to carefully and prayerfully call their next pastor.

TEACHING: The pandemic both afforded and necessitated an increase in opportunities for online classes for congregational leaders. In Spring 2020, we offered virtual forums and classes with information on the COVID-19 pandemic, guidelines for re-opening church buildings, and Crisis Stress Briefings. In Summer 2020, we offered virtual seminars on Racial Justice and presentations on Virtual Sunday School. In Fall 2020, we offered virtual forums on Voter Education, "Growing Young", and Grief and Congregational Systems. In Winter 2020 and the beginning of 2021, we offered virtual book studies on Racial Justice. On the recommendation of the Synod's Conference Deans, we are currently on break from learning events.

EQUIPPING LEADERS FOR MISSION AND MINISTRY (ELMM): LIVING STONES INITIATIVE: 75 congregational leaders over the three-year period will complete a retooled Equipping Leaders for Mission and Ministry (ELMM) program in four tracks: (1) Lutheran Bible study leader; (2) stewardship specialist; (3) community evangelist/catalyst; (4) assisting minister. ELMM successfully migrated to a Zoom format, which allows for more teaching time because people do not need to travel. ELMM is exploring other tracks for congregational leaders. We hope to offer a course in pastoral care especially for small congregations that rely and supply pastors.

YOUTH: LIVING STONES INITIATIVE: Our youth, especially those in smaller congregations, are afforded an additional level of youth ministry, to build on the excellent events provided by Living Water Ministries. Our Synod continues to benefit from training provided through the churchwide organization. In Fall 2020, several leaders from our Synod participated in an ELCA conference entitled "Growing Young." Afterwards, Pastor Sprang arranged for a follow-up Zoom presentation for our Synod. In November 2020, two youth and an adult leader participated in the ELCA National Youth Leadership Summit held via. Synod youth participate periodically in hang-out sessions via Zoom. Pastor Dan Schewe (Trinity/Grand Rapids) serves as our Synod Coordinator for the 2022 ELCA National Youth Gathering, which will be held in Minneapolis.

PASTORAL CARE: As has become our practice, Ann Stavros compiled the parochial reports (Forms A and C) congregations are required to complete annually to compare congregational membership and worship attendance from 2018 to 2020. This comparison is provided for your review in the appendices to this report. In reviewing these reports, we are not grading individual pastors/deacons or evaluating specific congregations. Rather, we are looking for trends in our Synod that will assist us in identifying congregations where Synod support and engagement might be helpful. Of course, the Synod Staff is eager to help every congregation that asks.

I am inspired by and grateful for the congregations and leaders that have been faithful, steadfast, patient, and creative during the pandemic. We have seen congregations such as these grow stronger. As pastors and deacons often respond to those who are struggling, so the Synod Staff is most often involved with congregations struggling with health and viability.

The COVID-19 pandemic necessitated that the Synod provide guidance on topics including congregations returning to in-person worship and community, conducting remote meetings, and so-called "virtual communion." COVID-19 also presented a new "pastoral care" issue as pastors (often with underlying conditions) and councils (often 2-3 members) could not find common ground on protocols for the congregation. I (often accompanied by Pastor Anderson) attended council meetings via Zoom to try and help them find a way forward together. Three pastors resigned over this issue. My weekly "Take One" Video for March 15, 2021 focused on the topic of bullying. While I cited my own experience, I made the video in response to emotional calls from pastors who had borne all the bullying they could take. The video stimulated a great deal of conversation as both pastors and lay people reached out to me to share their support of my ministry and relayed their own stories of being bullied. Constitutionally, it is the responsibility of the congregation council to discipline members who act in ways inconsistent with the gospel, even toward their pastor. The Bishop is available to provide advice and counsel.

In addition to helping negotiate congregational conflicts, which increased during the pandemic, our pastoral care of congregations increasingly involves issues of *sustainability* and *partnership*. LIVING STONES INITIATIVE: Struggling congregations receive accompaniment and assistance to realistically assess their sustainability and, where desirable, to partner with neighboring congregations, both ELCA and full communion partners.

Sustainability: In 2019, I reported that one model projects that 40% of ELCA congregations will complete their ministry by 2040. COVID-19 accelerates unviable and at-risk congregations on this trajectory. Fear that congregations will not "survive" causes some to engage in at-risk behavior, so members do not go elsewhere. Others attempt to reduce expenses, chief of which is the pastor. There is often an underlying COVID-19 related issue. In these circumstances, I am laying out the process for ending a pastoral relationship and apprising congregation leaders of the realities of relying on supply pastors, particularly in a pandemic. I do not expect all our congregations will emerge from the pandemic. Neither the Synod nor the bishop has decision-making power in determining what will happen to congregations that are not sustainable. Nor does the Synod and bishop have the responsibility and resources to prolong a congregation's life. When invited to do so, the Synod has the responsibility to actively accompany congregations through the slow, and often painful process of discerning their future.

PARTNERSHIP: To succeed, partnerships must be about more than survival and saving money. The heart of successful congregational partnerships is the synergy that results from a commitment on the part of both congregations to shared mission. In any successful partnership, the stronger congregation turns out to be the one that is willing to give up and change the most. We suggest, in normal times, if congregations can (a) worship together, (b) study together, (c) fellowship together, and (d) serve the community together, all in a sixmonth period, they can potentially partner. As congregations consider partnering, Pastor Sprang has provided resources on Cooperative Ministry, which are available on the Synod website: https://www.mittensynod.org/mission/cooperative-ministry/

Jesus says, "If any want to become my followers, let them deny themselves and take up their cross daily and follow me. For those who want to save their life will lose it, and those who lose their life for my sake will save it" (Luke 9:23-24). We begin conversations about partnership by asking congregations what they are willing to "give up" for the sake of mission and the gospel. Typically, the "sticking point" is worship time.

I expect many congregations will choose completing their ministry over partnering, trusting that their congregation will be there for as long as they need it. We have learned that, by the time some congregations seek partnership, they have declined to a point that, regrettably, they are no longer a viable partner. Timing in these matters is critical. It is better to partner when congregations have something to bring to the table.

COMPLETING THEIR MINISTRY: Jesus said, "Very truly, I tell you, unless a grain of wheat falls into the earth and dies, it remains just a single grain; but if it dies, it bears much fruit. Those who love their life lose it, and those who hate their life in this world will keep it for eternal life. Whoever serves me must follow me, and where I am, there will my servant be also. Whoever serves me, the Father will honor" (John 12:24-26). Saint John's/Saginaw held their last worship service on All Saints' Sunday, November 1, 2020. We commend this congregation to God's care as we thank the people of Saint John's for their faith and service.

MISSION/COMMUNITY ENGAGEMENT: As I compiled this report, I rejoiced that the North/West Lower Michigan Synod continues to grow as a publicly engaged church. Thank you for your care, courage, compassion, and commitment.

COVID-19 GRANTS: The ELCA awarded our Synod \$62,000 in COVID-19 assistance grants. Our Synod awarded these funds to 24 congregations who used them to provide food and shelter in their communities. Using Synod outreach funds, we also established education grants. These grants were awarded to six congregations who partnered with their local school districts to assist with virtual education. We estimate that 2100 lives are touched each week by these grants. I am grateful to Pastor Sprang for his administrative leadership in this effort.

REVIVE: LIVING STONES INITIATIVE: 18 congregations participating in REVIVE, a 2 year-long vitality program developed specifically for our Synod. Since congregation teams cannot meet in person, REVIVE is pivoting to videos that they can use. Examples include videos on "Growing Young" and Outreach to Millennials and Generation X. Videos and resources can be found on the Synod's website: https://www.mittensynod.org/mission/revive/. In Fall 2020, six people completed the ELCA's Vitality Training, which was held virtually.

DISASTER RESPONSE: Pastor Sprang continues to take the lead in representing the Synod and Lutheran Disaster Response in the Mid-Michigan Flood Recovery. The Synod received \$28,345 in donations to support those affected by the flooding. So far, \$9,425 has been spent on food and building supplies given through our congregations in the five-county area. We are currently investigating the possibility of bringing a virtual Camp Noah for children who are victims of the flooding. We also sent a disaster response gift to the Gulf Coast Synod to help with the winter storms in Texas.

Welcome: Living Stones Initiative: Our Synod makes a renewed commitment to discuss ways to welcome all God's people.

RACIAL JUSTICE: Under Pastor Anderson's leadership, we completed our second cohort of Introduction to Social Justice, a six session Zoom course through Justice Leaders Collaborative. We are committed to making racial justice a priority through August 2025. We learned that it is appropriate and helpful to continue to offer this introductory course for pastors and congregational leaders. We also hear that some are ready for a course that moves deeper into racial justice. We recognize that concrete action best takes place on the congregational, rather than the synodical, level. We also seek a broad based "leaven" (Matthew 5:13-16; 13:33) across our Synod, rather than a few people passionate about this issue. Pastor Anderson welcomes your input. I am grateful to Pastor Anderson for leading a weekly book study on racial justice via Zoom for several months.

AMMPARO (Accompanying Migrant Minors with Protection, Advocacy, Representation, and Opportunities): Pastor Ellen Schoepf serves as coordinator of our Synod's AMMPARO initiative, which is the ELCA's response to unaccompanied minors who cross our border. The ELCA reports the need is especially great in Grand Rapids; I will meet with representatives of Lutheran Immigration and Refugee Services (LIRS), which has an office on our territory. As this situation involves children, it especially touches my heart and I regard it as a humanitarian crisis to which the Church must respond. I am grateful for the work being done by Faith/Okemos and congregations and leaders in Jackson and Michigan Center.

OPEN HEARTS, OPEN CHURCH is working with congregations exploring becoming Reconciled in Christ (RAC). As a bishop, I expect and hold our church accountable to respect the four perspectives acknowledged in the ELCA social statement, <u>Human Sexuality: Gift and Trust</u>. As one who has had Leviticus 21:17-20 quoted to me as biblical proof that my visual impairment disqualifies me from serving as a pastor (and bishop), I rejoice when congregations find ways to proclaim the LGBTQIA+ Community is not beyond God's grace and has a full share in God's service.

MINISTRY WITH PERSONS WITH DISABILITIES TASK FORCE: We convened the Ministry with Persons with Disabilities Task Force, under the leadership of Pastor Clay Bates, in January 2021. The group completed four weeks of training with All Belong and is now formulating a plan to increase awareness and assist congregations in our Synod.

EMPOWERING LEADERS

RECRUITMENT: LIVING STONES INITIATIVE: 20 candidates for rostered ministry are identified, accompanied, and supported. We rejoice that five people in our Synod are discerning a call to public ministry and whether seek to enter candidacy and attend seminary. Pastor Anderson, Director of Candidacy for our Synod, worked with Directors of Candidacy from the other Region 6 synods (Southeast Michigan, Indiana-Kentucky, Northwest Ohio, Northeast Ohio and Southern Ohio Synods) to plan and present a discernment retreat. This retreat is a yearly event for people who are exploring their vocational call and discerning if God might be calling them to rostered ministry in the ELCA. This year, it was held virtually on March 5-6, 2021.

CANDIDACY: The Conference of Bishops established a first call process in which seminary graduates will ordinarily return to their home synod. Bishops will work together to help seminary graduates address their own needs and desires and the needs of the Church. In synods such as ours, where bishops have not had a major role in candidacy, the bishop will now do so. I have begun "Bishop's interviews" with our 12 candidates.

In previous years, the Southeast Michigan Synod and the North/West Lower Michigan Synod had a joint Candidacy Committee. However, to better facilitate the new first call (assignment) process, Bishop Kreiss and I determined that each synod would have its own Candidacy Committee. Pastor Anderson is overseeing the reorganization of our Synod's Candidacy Committee, which under the leadership of Pastor Haley Vay Beaman, is working well. Pastor Anderson is also spending time securing internships for students attending seminary via distance-learning. We will place three interns beginning Fall 2021.

FIRST CALL: With all of the ELCA bishops, I continue to spend considerable time implementing the new first call (assignment) process. Every newly ordained pastor or deacon in the ELCA is required to participate in First Call Theological Education for the first three years after ordination. It includes continuing education events held in each synod. Our first call pastors participated in the Introduction to Social Justice course and will be participating in a virtual retreat for all first call pastors and deacons in Region 6 on April 26-27, 2021. Pastor Anderson will be assisting with the planning of this event.

CONTINUING EDUCATION ROSTERED MINISTERS & CONGREGATIONAL LEADERS: LIVING STONES INITIATIVE: Rostered and congregational leaders receive increased opportunities for inspiration and continuing education. In addition to the Zoom classes listed above, our Autumn Leadership Event was a two-day conference via Zoom on addressing polarities. 18 leaders attended the online "Ignite the Church" event sponsored by the Florida-Bahamas Synod and recommended by the ELCA. I am grateful to Pastor Anderson for attending with them while Pastor Sprang was away because of the death of his father.

ROSTERED MINISTER INDEBTEDNESS: LIVING STONES INITIATIVE: Rostered ministers are relieved of some measure of educational indebtedness. For the 2021 program year, we were able to award three grants out of the six applications we received. I thank Pastor Jessica Hahn and her team for faithfully carrying out this annual work. I am also grateful to those who support this ministry.

PASTORAL CARE: Our Synod's Conference Deans hold regular conference meetings via Zoom for conversation, to share ideas, and facilitate support. The Synod Staff attends those meetings when invited and also holds a meeting with the deans every two weeks. We find them to be very helpful and supportive. We have also held a check-in with the Bishop and Holy Week Devotions for all rostered ministers via Zoom.

Pastors, deacons, and their families experience the pandemic, the aftermath of the election, and the siege on the Capitol, like everyone else. Their challenge is to find a safe and appropriate outlet for their feelings and actively minster to people they strongly disagree with or who strongly disagree with them. I am concerned for our Rostered Ministers in light of this added stress.

DISCIPLINE: After more than a year of consultation and writing, the ELCA Committee on Appeals has completed a draft for the revision of *Definitions and Guidelines for Discipline*. The document has been reviewed by the Conference of Bishops, as required by the constitution, and now will be considered for possible approval by the Church Council at its April 2021 meeting. The document may be found here and the report from the Committee on Appeals concerning its work may be found here.

ROSTER: The report on changes in the roster is appended to this report. I am grateful to Ms. Ann Stavros for assisting me in this work. As the person ultimately responsible for maintaining the roster for our Synod, I am very concerned about inaccuracies and omissions. If you find omissions or inaccuracies, please let us know. If you notify us prior to the assembly, I will amend the roster report as part of my oral report to the assembly.

STRENGTHENING CONNECTIONS

COMMUNICATIONS: Some reading this report are voting members attending their first Synod Assembly, and perhaps are being "introduced" to synodical ministry. I therefore want to review some of the ways we communicate, many of which are maintained by Director of Communications, Ms. Chelsey Satterlee.

Our **Mitten Synod Webpage** provides news, information, and resources for congregations and leaders: http://www.mittensynod.org. A **Weekly Update** is sent to our Synod's e-mail distribution list every Tuesday at 10 AM and contains news for the week. The **Bishop's Newsletter** is published on the 15th of each month and also sent to our Synod's email distribution list. It includes longer articles, snapshots of upcoming events, call process updates, and an update on the Synod's finances. You can subscribe to receive both these resources by entering your email address on our Synod webpage. Click the link included in this paragraph and scroll down on the right side of the page to the box that says sign-up.

On **Facebook**, we have both a page and a group. The page, North/West Lower Michigan Synod (Official),¹ is where the Synod Office posts news. The group, North/West Lower Michigan Synod,² is a place for conversation where anyone can post. Posts to this group are not approved or endorsed by the Synod.

I maintain a personal webpage that includes my public schedule—*CraigASatterlee.com*. Many find this helpful when planning events that involve the bishop. http://craigasatterlee.com Most Mondays, I produce a short video called **Take One**, in which I review my weekly schedule, comment on happenings in the Church and the world, and offer reflections on the scripture readings from the Revised Common Lectionary for the coming Sunday. As its name suggests, *Take One* is recorded in one and only one take; there are no do-overs. I serve as both host and cameraman. You'll find a link to each *Take One* segment in the *Weekly Updates*. I also post a link to Facebook and my webpage.

CAMPUS MINISTRY: Each semester, Pastor Sprang convenes a Lutheran Campus Ministry Day of consulting and collaborating among those engaged in campus ministry in our Synod. We are very excited about what we see and hear happening at One Community (University/East Lansing), Matrix (Trinity and St. Peter/Battle Creek, Savior and Trinity/Kalamazoo, and Prince of Peace/Portage), and Immanuel/Mount Pleasant. In April 2021, Synod Council will consider a proposal to explore campus ministry at Grand Valley State University through Bread of Life/Hudsonville. We thank you for your support of campus ministry both in sending the names of students from your congregations who attend Michigan State University, Kalamazoo College, Western Michigan University, Central Michigan University, and Grand Valley State University, and through Synod Mission Grants.

50TH **ANNIVERSARY OF THE ORDINATION OF WOMEN:** A committee continues to work on a Gala and festive worship service scheduled for October 2021. A sermon collection written by women clergy for the 2020-21 liturgical year is now available: https://jubilee504010.wordpress.com/ A video of interviews with women clergy will be forthcoming.

ADMINISTRATION

COMMITTEES: BRIDGEBUILDERS: Pastor Larry Foster informed me of his intention to retire as leader of the Bridgebuilding Team in 2021. Our Synod and, indeed, the entire Church are indebted to Pastor Foster for his leadership. I have given considerable thought to how this vital ministry could evolve. However, before making any decisions, Pastor Anderson and I will engage the members of the team in individual conversations and determine the next chapter in this important ministry.

Synod Office: The Synod Staff continues to work from home with a weekly staff meeting via Zoom. Ms. Renee Dixon and Ms. Ann Stavros drop by the office for mail, filing, etc. We will continue this pattern indefinitely. When we do return to offices, our Traverse City desk will relocate to Calvary in Elk Rapids as Samaritas needs the office in its assisted living facility in Acme. We are grateful for their hospitality and for Calvary's welcome.

In the aftermath of the COVID-19 pandemic, the Synod will consider what configuration of office space best serves our mission. Whatever is decided, this will be a gradual process because of the necessity of migrating paper files to electronic files.

Synob Staff: Our Synod Staff experienced a good bit of transition since our 2019 Synod Assembly. We bid farewell and Godspeed to Rev. Dr. Chrysanne Timm and congratulated her on being called as the pastor of Bethany Lutheran and the rector of Saint Christopher Episcopal, both in Northport. Ms. Rebecca Bossenbroek (Equipping Leaders for Mission and Ministry and Director of Finance), Ms. Renee Dixon (Executive Assistant to the Bishop), Ms. Chelsey Satterlee (Director of Communications), and Ms. Ann Stavros (Office Manager) all manage secondary "day jobs," so we introduced flexibility into the workplace even before the pandemic.

When everything shut down in March 2020, Ms. Cathy Satterlee (the Bishop's Driver) was furloughed and Ms. Chelsey Satterlee (Director of Communications) was asked to increase her hours to keep up with communication needs in light of the transition to video communications. I've continued to value conversation with our Synod Attorney, Ms. Dawn Brackmann, when necessary as we have navigated legal issues.

Like every other pastor, Pastor Roseanne Anderson, Pastor David Sprang, and I had to figure out how to do everything new and how to do things together when we could not physically get together. Thankfully, we have a great reservoir of experience, friendship, and trust on which to draw. Following the advice of experts in natural systems theory, we worked with a counselor during the summer of 2019 to process the events of the 2019 Synod Assembly. In February 2020, we spent a week of continuing education at a conference together. Through Zoom and text, we each have an office on the same virtual hall.

I truly miss gathering together at the Synod Office on Wednesdays, especially to worship together and share the Lord's Supper. Even more, I cherish that the staff gathers around a virtual table every Wednesday via Zoom. Meeting in-person means Rebecca and Chelsey cannot be with us, so even after the pandemic I imagine we will end up with a hybrid arrangement. Being a Synod Staff member during a pandemic has turned out to be even more of a team sport. I am grateful and proud to serve this team; God has indeed richly blessed our Synod, congregations, and leaders by their service. I publicly thank them and I daily thank God for them. We will not bring them onto the stage at Assembly, so please offer a word of thanks as you have opportunity.

MISSION SUPPORT: I am grateful that mission support for 2020 was only down 3.9% compared to 2019. In 2020, 41 congregations increased their mission support. We continue to receive gifts from individuals, including a gift of \$4500 to Living Stones. Thank you!

"Even if you are exiled to the ends of the world, from there the Lord your God will gather you, and from there he will bring you back." (Deuteronomy 30:4). Until God gathers us together in health and safety, I am grateful to be gathered with you on Zoom.

Indeed, Bishop Satterlee is Legally Blind

I assume that, for some, a bishop (teacher, scholar, administrator, ordained minister, someone who has power over you) who also manages a disability is a new experience. Over the years, students and colleagues have found the following "protocol," which I originally developed for the permanent community of the Lutheran School of Theology, helpful. I share it in the hope that it will be helpful to you as well.

- 1. I am legally blind. I have less than 10 percent of normal vision with correction. I do not know what that means, since I have never seen "normally." I am the expert on my vision and how it impacts my life and work. Bring all questions and concerns about my vision to me. Making assumptions and conclusions about my abilities and limitations without consulting me is inappropriate.
- 2. Since I cannot see faces, I know people by voice and appreciate being reminded of people's names in order to match them with voices. When you greet me, tell me your name. My closest friends know and do this. When I know your voice, I will tell you. I only hold myself accountable to recognize my wife, daughter, and mother "on sight."
- 3. Cluttered corridors and walkways can be hazardous for me, particularly when obstacles (chairs, dogs, furniture, construction) are placed unexpectedly. Please keep the hallways outside my office clear and do not rearrange or remove furniture from my office.
- 4. If you want to be certain that I receive information, use voice rather than email and provide hard copy rather than file attachment. I do not hold myself accountable for information posted on signs and bulletin boards.
- 5. Dr. Conrad Heyner, my first ophthalmologist, determined that it takes me 2 times longer than average to read and write. I am therefore very disciplined in managing time. Last-minute assignments, unexpected delays or interruption of services, and changes in schedule can be particularly burdensome for me.
- 6. I read English text in standard font, though 14 to 16 point is easier. I do not read cursive handwriting; someone reads it to me. Reading Latin, Greek, French and German are much more laborious undertakings.

- 7. Tasks such as locating a library book on the shelves, working office machines, and filling out forms are difficult for me. I sometimes get frustrated that I cannot do these tasks. I may ask for help or suggest ways around these tasks. As far as possible, please be accommodating.
- 8. Pointing and giving directions such as. "That way," are not helpful. Try to be descriptive and concrete.
- 9. I will address questions and concerns about my disability directly. It is inappropriate to do it for me.
- 10. I will be consulted in order to determine ways that are most helpful both to me and the synod and church. It is inappropriate to unilaterally decide for me what and how much I can and cannot do.
- 11. I applaud and am deeply committed to our church's mission of bringing the power of the Gospel to bear on issues of diversity related to race, gender, culture, sexual orientation, and the environment. At times, I find this limited understanding of diversity painful because those most passionate about these issues are often the most oblivious, insensitive, add in tolerant when it comes to issues of disability. I hope and pray for that time when the ELCA naturally counts persons who live with disabilities among the diverse voices that the church is called to struggle with and by which the church is blessed. In the meantime, I need to be disciplined in spending time in communities more attuned to issues of disability so that I will thrive in our church.
- 12. I am sympathetic to the appropriate use of technology in learning and worship. Since I do not participate and learn visually, I often experience this kind of class and meeting as a waste of valuable time; I also experience much technology-driven worship as personally exclusive. Please do not equate my lack of personal participation with antagonism toward the endeavor.
- 13. Address questions and comments about this protocol to me or to the appropriate administrative officer. Do not make comments to my family.

Report of the Synod Vice President Sandy Schlesinger

I am so amazed and impressed at the ingenuity and creativity of our synod and congregational leaders and staffs as they quickly adopted new technologies and safety practices in order to carry forward with their important mission and ministries — from on-line worship services to synchronized video choral anthems to Zoom meetings and training sessions. We have built skill sets and adopted technology platforms that will serve us well going forward as we move on (hopefully soon!) from the pandemic protocols we continue to manage. Thank you to all of our rostered and lay leaders who led with courage over the past year — your efforts have made a clear difference in our ability to continue to minister to and serve those in need across our synod. Well done!

It is a great honor and privilege to serve as the leader of this diverse group of energetic and committed leaders who give of their time and talents to further God's mission across the synod. In particular, please join me in thanking the members of the Class of 2021 who, if not re-elected, complete their current terms of service this coming August – their leadership, engagement, and dedication to the mission and ministry of the synod is truly appreciated!

Looking forward, the Nomination Ballot at this year's synod assembly includes 14 positions (Positions A through N) aligned to the Synod Council (refer to the table below). The cancelled 2020 synod assembly resulted in positions that either were extended or remained vacant over the past year resulting in a significant imbalance in terms. To address this imbalance, Synod Council made appointments or approved

extensions for six current positions (Ashley, Bates, Carter, Hahn, McCorkle, and Trevarthen –in blue font in the table) that are on the ballot this year for synod assembly ratification. Eight additional positions are also on the ballot for election (in red font in the table). Going forward, the number of positions changing over each year should be more evenly balanced.

 with the most recent U.S. Cost of Living Allowance (COLA) increase; recommendation of 2022 N/W Lower
 MI Synod Compensation Guidelines (including a 2% starting base salary increase) for approval by this
 Synod Assembly
- Revision of 2020-21 (last year) and 2021-22 (current year) Fiscal Year Budgets to align with realistic
 expectations for mission support and planned spending in light of the COVID-19 pandemic;
 recommendation of the 2022-23 (next year) Fiscal Year Budget for approval by this Synod Assembly
- Approval of the new Disabilities Ministries Task Force aligned to the Synod's Publicly Engaged Church Table

- Approval of dates and locations for the 2022 and 2023 Synod Assemblies: May 12-14, 2022 (Thursday-Saturday) in Mt. Pleasant and May 7-9, 2023 (Sunday-Tuesday) in Mt. Pleasant. Both meetings are planned to be in-person and will be held at the Mount Pleasant Comfort Inn and Suites Hotel and Conference Center.
- Communication and clarification of synod policies and procedures as questions and concerns arise
- Continued support and engagement in leadership training across the synod, including Equipping Leaders for Mission & Ministry (ELMM), Boundary training, and Social Justice training
- Leading all aspects of Human Resource management for the synod staff. This includes performance
 reviews, compensation management for synod staff (called, support, and deployed), approval/oversight of
 sabbatical plans for called staff, addressing resource needs as staffing changes take place, managing
 inquiries (confidential and otherwise) from synod members relative to synod staffing and other issues or
 initiatives
- Support of the sabbatical for Assistant to the Bishop Pr. Chrysanne Timm in the summer of 2019 followed by her transition to a new call in the Grand Traverse conference
- Continued partnership with and encouragement and support of Bp. Craig Satterlee, Asst. to the Bishop Pr.
 Roseanne Anderson, and Asst. to the Bishop / Dir. of Evangelical Mission Pr. David Sprang as they carry
 out strategic/constitutional responsibilities across the synod and beyond on behalf of all congregations
 and synod members
- Fulfillment of many other responsibilities including approval of roster/congregation changes, management of changes to synod and/or congregation constitutions, budget development and fiduciary oversight of synod-led initiatives, appointments of members to serve on synod committee/boards, synod assembly preparation and oversight, providing support for synod events as requested by the bishop, and so on . . .



Candidacy Committee Report

The committee accompanies candidates in their journey toward becoming Ministers of Word and Sacrament (Pastor) and Ministers of Word and Service (Deacon). People who have discerned a call to rostered ministry in the ELCA enter the candidacy process through which individuals develop an understanding of four basic principles: 1. We are church; 2. We are Lutheran; 3. We are church together; 4. We are church for the sake of the world.

The path to rostered leadership in the Evangelical Lutheran Church in America is a partnership between candidates, congregations, synods, seminaries, and the Churchwide expression of the church. The Candidacy Committee encourages all members of congregations to identify, nurture, support and encourage persons who possess gifts for rostered ministry in the ELCA.

For several years, the North/West Lower Michigan Synod and the Southeast Michigan Synod worked together as one committee known as the Michigan Multi-Synodical Candidacy Committee. With the Assignment/First Call Process moving from a Churchwide Process to a Regional Consultation Process where candidates are initially assigned to their home synod, each synod in Region 6 now has their own separate Candidacy Committee.

Candidates

The NWLM Synod currently has 13 students in the candidacy process. Three students have been recently entranced and will begin their academic work during the summer or fall of 2021. Five students are continuing their academic work prior to endorsement for internship. Three students have been recently endorsed and are awaiting an internship assignment in the NWLM Synod. Two students have completed or are nearing completion of their internship and course work and are awaiting a final approval panel prior to ordination.

Equipping Leaders for Mission and Ministry

We envision a community of scripturally grounded, mission-driven, spirit-led disciples who support the work of their pastors in their congregations and communities and who give voice to the many ways we are church together. Scripturally grounded disciples lead with confidence. Mission-driven disciples energize the church. Spirit-led disciples encourage and empower others. We celebrate leaders who invest time and energy in their faith formation and continued education!

In 2019, Equipping Leaders for Mission and Ministry began retooling the program to train participants in four tracks: 1) Lutheran Bible Study Leader, 2) Stewardship Specialist, 3) Assisting Minister, 4) Community Catalyst. This fall, we are adding a fifth track, Pastoral Care Assistant.

We recognize and thank those who provided instruction virtually this past year: Dr. Barbara Kaiser (ret.) of Wittenberg University, Dr. Wally Taylor (ret.) of Trinity Lutheran Seminary, and Dr. George Heider (ret.) of Valparaiso University.

We value the support and guidance of mentors who attend the retreats and facilitate conversation and spiritual growth among participants: Tracy Teich from Messiah in Bay City and Connie Teddy from St Paul in Greenville.

We also thank the Board of Governors who guide and direct the program: Bishop Satterlee as Synod Liaison, Pastor James Smith as Chair, along with Chris Brandt from St John in Grayling, and June Scarborough from New Life in Spruce. Pastor Clay Bates concluded his term as chair effective February 1, 2021, and we appreciate his leadership and dedication.

Synod Assembly 2022 will recognize in person those who have completed three years of commitment to ELMM: Nancy Holderread of Bethlehem in Lansing, Barbara and David Marquette of St Peter in Battle Creek, Heather Nielsen of Settlement in Gowen, David Osim of St John in Grayling, and Lee Wolken of Immanuel in Big Rapids.

It is likely someone in your congregation would find Equipping Leaders for Mission and Ministry to be right for them at this stage of their faith journey. We ask you to give this some thought and invite them to explore the program at www.elmm.org.

Global Mission Table

The Global Mission Table met once this past year via ZOOM to discuss the needs of our partner, the Christian Lutheran Church of Honduras. We maintained close contact with that church as they sought ways to address COVID in their communities. Just like in the US, they cancelled programs for which we provided financial assistance due to the restrictions placed upon them. Yet, they sought ways to address the needs of their communities, so we gladly affirmed moving our financial support to the areas they needed to address. Communication with this church has been fantastic, and we have been blessed to hear how the ICLH is coming together to help local communities in the wake of both COVID and of hurricanes Eta and Iota. Though we were not able to send teams to Honduras last year and expect not to do so in 2021, the partnership remains strong, and we look forward to sending a team when it is possible.

Many of us remain connected to the church in Papua New Guinea through their Facebook page. This provides both helpful information and insights into their internal squabbles. We were sad to hear of the death of ELC-PNG Papua District President Rev. Gundu Guenu Kagl. He passed away in early March and was the bishop of our companion synod. We offer prayers for our companions as they begin the process of selecting a new Bishop.

We continue to encourage congregations of the synod to enter into global mission partnerships directly. Such relationships remind us that the church is bigger than congregation, synod or even the ELCA. Those who have such relationships receive regular updates from their global mission partners. Many of the ELCA's global personnel remained in their settings and served in exemplary ways.

What is Matrix Campus Ministry?

Matrix Campus Ministry is a partnership between five area ELCA congregations who created a new way to do ministry with young adults in the greater Kalamazoo area.

We choose to share the ministry as an extension of our congregations and invest our funding into the students. Our goal is to help them build intergenerational relationships within the church and introduce students to mentors in their chosen fields. We also offer paid internships and opportunities to serve within the partner congregations. Our paid interns focus on projects that blend their skills and interest with the ministries of the church. We aim to accompany our students during this transitional time between specialized youth ministry and participation in a multi-generational congregation and show by example what it means to be church together.

Why call ourselves Matrix?

The definition of a matrix is an environment in which something develops. That's our goal – to create an environment for these young adults where they can connect with people of faith who will support and encourage them, grow in their skills and passions, and have the opportunity to lead projects that benefit the surrounding community.

Connect. Grow. Lead. See what develops.

COVID?

COVID slowed us down, but it didn't stop us. We continued to connect with our students through Zoom and build on our relationships with them. Going virtual made our meetings more accessible, but it became more challenging to offer opportunities to integrate into congregational life. Still, those opportunities will return, and we plan to move forward with flexibility and resilience. As with everything in this time of uncertainty, we trust the Holy Spirit to guide us.

Meet the interns!

Emma McCleary is studying occupational therapy, and her project this semester is The Pad Project. She partnered with a high school student at Prince of Peace. They are working to raise awareness of the stigma surrounding menstruation, which results in fewer donations of menstruation products to women's shelters. They are putting together a donation drive and a virtual talent show, Gong-Show Style, to support the YWCA domestic assault shelter in Kalamazoo.

Kayla Kennedy is studying art education, and she is leading a multi-congregational fellowship event online. She created Paint, Sip & Socialize as a way to bring together the families of our congregations during this time when coming together in person isn't possible, leading a glassware painting party and allowing them to interact and have fun.

Ejiro Enajero is studying performing arts and non-profit administration. She is passionate about helping those experiencing poverty and homelessness. In Kalamazoo, we have two encampments of folks living in tents and makeshift shelters, and while there are strong efforts to provide housing, it isn't happening fast enough. There is a Meal-Train sign-up to give meals a few times per week to our neighbors in these encampments, and Ejiro made that her project. She coordinated the preparation of 50 healthy, home-cooked meals, and we handed them out in the encampments.

Alison Barnett is a business marketing major who is working with St. Peter to build their website. They hope to use their degree to open a bakery, so for their project, they created Nailed It – Cupcakes! Alison baked the cupcakes and put together kits with decorating supplies. Then, during this online event, they taught the participants different decorating techniques. Their project was originally going to be an outreach event to other college students, but it was early days, and most students were virtual. We did a quick pivot and offered the event to our congregation families, and they loved it!

Finally, not all of the young adults involved in Matrix have decided to do an intentional internship project. Amanda joins us for meetings and events, and cousins, Shanice and Valerie, volunteered to help with Ejiro's meal project and are eager to continue volunteering. We are building connections, one student at a time.

The table met in person in January of 2020 and after that all meetings were virtual. The synod supports congregations in grant programs with the ELCA with partnership funds including

- Sudanese Christ Lutheran Community, Wyoming Synodically Authorized Worshipping Community African National
- Trinity, Battle Creek Vital/Strategic Congregation
- Zion, Saginaw Strategic/Ministry in Poverty
- Harbor of Grace, Muskegon Strategic/Consolidated Congregation.

In 2020 in partnership with Bishop Satterlee the table took on the temporary role of reviewing recommendations for COVID-19 Response Grants. These funds were distributed to synods by application and need. Pastor Sprang and Bishop Satterlee reviewed the applications and recommended amounts to the table. The synod has received \$65,000 from the ELCA's Covid Campaign and distributed \$57,150 as of March 31, 2021. The funds are prioritized for 1) Prepared Food Distribution and Food Commodities, 2) Shelter and Homelessness, and 3) Personal needs and baby supplies.

Since May 2020 when the first grants were made available a rough estimate is that the congregations of the synod were serving 2,180 people per week. Donating about 1,679 hours. These are above and beyond the normal contacts of food pantries, meal programs, housing, and baby and personal needs. This is remarkable and a blessing from God for the folks in the neighborhoods served by out congregations in the synod.

The synod's Vitality Initiative REVIVE has 11 congregation in the first and second cohort. There was an in-person training on February 1, 2020 and then the whole program moved online. REVIVE presented a webinar on Growing Young, sponsored four people to attend the ELCA Virtual Vitality Training, and supported 19 people to attend the Ignite the Church virtual event. REVIVE also has established resource files on the synod webpage: www.mittensynod.org/mission/REVIVE.

The table facilitated a zoom meeting in February 2021 for Lutheran Campus Pastors/Ministries with Pastor Lamont Wells, the ELCA's new director of Campus ministry.

Publicly Engaged Church Table

(Church in Society)

It goes without saying that 2020 was a challenging year for everyone. In so many ways it brought out the strengths of our Church, Synod, Democracy, and the World, as well as their weaknesses. It was a year which has caused us to rethink what is "normal", and what will it look like when it returns. In light of this the PEC Table continued the work of Advocacy primarily through its Task Forces --- Sexual Orientation and Gender Identity; Environmental; Hunger; Human Trafficking; and Synodical. During the year, the PEC also added Disability Ministries as an exciting new Task Force.

Due to the pandemic, the Bishop's directives for the Synod, and Governor Gretchen Whitmer and State mandates, some of the work of the Table was curtailed. There were no PEC grants provided during 2020 except for "seed" funds to initiate the Disability Ministries Task Force. In addition, two mini events scheduled for October were cancelled. The focus of the events was Martin Luther's concept of the Two Kingdoms, and the concept of the "Separation of Church and State". LSTC professor Dr. Marvin Wickware Jr. had agreed to be the presenter/facilitator of the events. However, the Table did pursue issues of immigration; for profit prisons; and supported the efforts of the Bishop and Synod as it tackled racial justice issues and lifted up anti-racism work. As we have moved into 2021 the Table will continue to pursue these issues along with others.

In 2021 the PEC Table will continue to work to help the Synod become more publicly engaged. Also, the Table will continue to meet one of its primary tasks--that of providing resources to those congregations seeking to implement creative and needed ministries in their respective communities.

Grounded in God's love and forgiveness, a publicly engaged church is well equipped to live and serve here and now, in the world, with all of its complexities, tensions and ambiguities.

We welcome anyone interested in social ministry to join us. There is always room for you at the Table.

Living Water Ministries - 2020 Report

Living Water Ministries did not operate summer programs in 2020 as a result of concerns related to COVID-19. The cancellation of our 2020 summer season came with the expectation of approximately \$200,000.00 in financial losses for the organization, however we were able to mitigate these expected losses through the increased generosity of our donors, securing a PPP loan, the reduction of expenses, and interest income from our ELCA Pooled Trust investment. In fact, we ended our fiscal year without incurring any financial losses while keeping our year-round staff employed.

Without summer programs, the work of Living Water Ministries has centered around fundraising, the implementation of new camp and donor management systems, facility renewal, program planning and more!

Fundraising - The loss of revenue as a result of the cancellation of our 2020 summer season was significant, however our donors rose to the challenge and Living Water Ministries had a 108% increase in donations in 2020 over the year prior!

New Systems - We've taken the time and space allowed by the pandemic to implement a new camp management and registration system that will help streamline our operations while also being more user friendly for our camp families. In addition to our new camp management system, we implemented a new donor management system that has allowed us the ability to cultivate and receive the generosity of our donors more efficiently and with greater ease for them.

Facility Renewal - Tied to the generosity of our donors and careful planning by our board, we finalized plans to begin the construction of the first phase in our facility renewal plan. A contractor has been selected and work will soon begin on a new, 2,100 square foot duplex cabin structure at Stony Lake. This new structure will house up to 24 participants, have in-cabin bathroom facilities, and a great room with kitchenette. This structure will also have electric baseboard heat for potential use on the shoulder seasons. Construction is tentatively scheduled for completion by November of 2021.

Program Planning - When camp does return in 2022 there will be adaptations to the way programming is implemented as a result of new learnings related to the pandemic. We continue to develop, redevelop, and revise strategies for program implementation, staff training, and health services as new information comes to light.

While we have come out of the first year of the pandemic in a strong position, the cancellation of our 2021 summer season presents similar financial and operational ramifications. In 2020, we centered our efforts around "restoring momentum" lost due to COVID-19. In 2021, we turn our attention toward "restoring hope" as we do the continued work of preparation in order to strengthen Living Water Ministries and provide the best season of programs we've ever had in 2022! We welcome your partnership as we solicit donations, recruit summer staff, and reinvigorate our camp families to participate in God's work through our mission in 2022 and beyond.

Samaritas[™] 2020 Year-In-Review Special Report

On the Frontlines of COVID-19

In March, COVID-19 arrived in our communities, closing schools and businesses and changing our way of life. The safety and stability of children, families, and seniors in our care is always Samaritas' top priority. We quickly established a COVID-19 emergency fund and called for help. And Samaritas Nation answered.

With the support of Samaritas donors, congregations, the community, and corporate partners, we provided \$1.7 million in COVID relief for our most vulnerable citizens. Samaritas Nation supported critical safety supplies, meals for thousands of hungry families and seniors, and technology for foster children, seniors, refugees, and families throughout the state coping with the pandemic. Thank you!



In December and January of 2021, residents and staff in our senior living communities in Cadillac, Grand Rapids, and Bloomfield Hills became some of the first in the state to receive COVID-19 vaccinations. What a historic moment! Samaritas continues to be on the frontlines of this pandemic by providing essential services to steadfastly secure the safety and well-being of all we serve.

Samaritas Launches Substance Use Disorder Services



In April, Samaritas launched a new service line across the state – Substance Use Disorder (SUD) Services. The SUD team is committed to serving our communities with meaningful, evidence-based behavioral health interventions that work in tandem to support substance abuse treatment. Our SUD treatment program offers holistic, person-centered care to address substance use disorder, depression, anxiety, or other behavioral health concerns.

Throughout Michigan and the Nation, opioids, fentanyl, and

multi-substance abuse are major contributors to increased overdoses. Medication-Assisted Treatment and drug testing are essential parts of our treatment spectrum, allowing us to keep people safe and engaged in treatment. Samaritas SUD clinics operate in Holland, Grand Haven, Charlotte, and Kent County, with Oakland County and additional locations opening in 2021. Samaritas is committed to combatting this public health crisis, providing hope and a path to recovery for so many struggling with addiction.

West Michigan Child and Family Campus and Senior Affordable Living Community Virtual Ribbon-Cutting

After nearly a year of development, on November 20th, Samaritas opened our newest Senior Affordable Living Community and West Michigan Child and Family Campus, both located on the former grounds of the historic St. Joseph Seminary in Grand Rapids. In addition to serving as the West Michigan headquarters for



Samaritas, this campus will offer essential collaborative services, including foster care, adoption, senior care, refugee, and people with disabilities to various groups of vulnerable people.

Freedom Village -New American Families Find Home

On October 8th, Freedom Village opened its doors to six of Michigan's newest refugee residents. The virtual event included a live-streamed ribbon-cutting with families receiving keys to their new homes. Freedom Village has three two-family homes in Hamtramck that were refurbished and redesigned for families. This construction project was made possible by a partnership between Samaritas, Wayne County, Wayne Metropolitan Community Action Agency, and Hamtramck.

In addition to Samaritas CEO, Sam Beals, these dignitaries also took part in the ribbon-cutting ceremony: Wayne County Executive, Warren C. Evans, Assistant County Executive at Wayne County, Khalil Rahal, CEO of Wayne Metro, Louis Piszker, Hamtramck Mayor, Karen Majewski, and representatives from Commissioner, Martha G. Scott's office.

With a history as one of the largest refugee resettlement organizations in the state, Samaritas welcomes refugees as New Americans. We work to ensure they are no longer defined by what has happened to them but by who they are and all they have the potential to be.





Keeping Families Together and Children Safe - Family Preservation Services

As the largest private foster care and adoption organization in Michigan, Samaritas provides a continuum of care through reunification and family preservation, foster care and adoption services with an intentional shift to serve more families in preservation in order to help prevent a separation at all. Right now, our family preservation programs serve

1,600 youth annually and are designed to keep families together by intervening with intensive home-counseling to prevent children from being removed from their home.

In 2020, Samaritas received 13 new Family Preservation contracts growing our reach by 15 counties throughout the state, making us one of the top organizations in Michigan providing these types of services. These new contracts enable Samaritas to help an additional 600 families annually. Keeping families together reduces trauma, encourages brighter futures, and supports our mission of meeting people where they are on their journey and helping to change that trajectory.





Report to 2021 Synod Assemblies

Greetings in the name of our Triune God!

For us, as for so many, 2020 will be remembered as "the year of COVID-19." Just as Jacob wrestled with God at the river Jabbok until he received a blessing (Genesis 32:22-32), we have wrestled to identify the blessings Trinity Lutheran Seminary has received through these challenging times.

As part of Capital University, we have access to a wealth of technology-related resources that made the pivot to remote instruction much easier than it would otherwise have been. Both our teaching and our worship life have benefited from new tools and training. As part of a university with graduate programs in nursing, we have benefited from the wisdom of our nursing faculty and their connections with public health leaders in Ohio as we have adopted safety protocols, regular on-campus testing for COVID-19, and now vaccination clinics.

We have also wrestled to turn the challenges of ministry during a pandemic into blessings. The M.Div. students who graduate in May 2021 will have spent the majority of their internship under pandemic conditions. The students who go out on internship this fall will have spent the majority of their Learning in Context (field experience) placements under pandemic conditions. Instead of focusing on a lost sense of "normal," we have named the importance of ministry lived out in particular places at particular times. Whether rostered or lay, we all experienced challenges and changes in how we do ministry and live together as church in 2020. Our students haven't missed out on the preparation they need. They've had the opportunity to be prepared differently, for the realities of today and tomorrow rather than the realities of yesterday.

We are grateful for our many faithful donors, our congregational partners, and this synod! Thanks to your generosity, we finished fiscal year 2020 (our second full fiscal year as part of Capital University) with direct operating expenses "in the black." Also, during the 2020-21 academic year, we were able to increase financial aid to the point that almost all Trinity students received full tuition scholarships.

Each time I report to you on behalf of the seminary, I ask these three things:

- Encourage potential candidates for ministry to explore Trinity Lutheran Seminary at Capital University.
- As you are able, consider making a financial contribution to support the work of the seminary.
- Keep us in your prayers!

SYNODICAL REPORT - SPRING 2021 Office of the University Pastors

With the whole church, we are mindful of the cost of this pandemic and continue to pray for all who have lost loved ones or have faced other hardships. The pandemic has impacted all colleges and universities, but through the ongoing challenges, Wittenberg found creative, profound ways to shine its unique light this past year through in-person learning, service, storytelling, music, art, and more.

Understanding that residential in-person learning is a cornerstone of the Wittenberg experience, we welcomed our students back to campus in August 2020 with extensive health and safety measures in place. Our COVID Response Team, which includes three alumni physicians, played a crucial role in providing guidance and recommendations to ensure a safe living-learning experience for our students. To date, we have remained in-person and are planning for in-person Commencement exercises on May 15.

As a University that challenges students to become responsible global citizens, to discover their callings, and to lead personal, professional, and civic lives of creativity, service, compassion, and integrity, we were also blessed again this year by the presence of two scholarship recipients of the ELCA's International Women Leaders initiative. Satta Sheriff, class of 2023, from Kakata City, Margibi County, Liberia, is currently double majoring in English and sociology with a concentration in criminology, while Evelina Chandran, class of 2022, from Kota Kinabalu, Malaysia, is pursuing math. Together, they are sharing their special light on campus as they pass on their knowledge, passion for learning, and global perspective with our community.

In pre-pandemic years, we would have gathered for large community events such as our annual Lessons and Carols for Advent and Christmas. While this was not possible in 2020, we were grateful for campus partners who helped to create a special virtual experience complete with choir performances stemming as far back as the 1960s. Faith-based, socially distanced demonstrations, devotions, and activities, all with digital components, helped to connect our community throughout the year.

Additionally, issues surrounding food scarcity saw a marked increase this year nationally and on our campus, and we responded. Our student food pantry, Campus Cupboard, expanded its physical footprint in October. We also received more than \$1,000 in donations from alumni, faculty, and staff to support the pantry's mission. Such generosity allowed us to distribute more than 900 meals this academic year, plus many other health and household items.

Lastly, we joined together virtually on March 11 for our annual Commit to Witt 24-hour day of giving, which resulted in a record \$560,000 in contributions. During the event, we also officially launched our \$100-million Having Light: The Campaign for Wittenberg University. The campaign looks to support all that defines the institution, especially the people, who inquire, create, inspire, and compete here; the place, where we come together as a community and welcome others to learn and grow; and the present, when the next generation of Wittenberg graduates learns to pass on its light.

Evangelical Lutheran Church in America Region 6 Archives

The ELCA Region 6 Archives continued to navigate the transition from the ELCA to Capital University in 2019.

 - Participated in ministry fairs at 3 synod assemblies: Indiana-Kentucky Synod, Southeast Michigan Synod, and Northeastern Ohio Synod
 - o Presented a Mission Moment at the Indiana-Kentucky Synod Assembly
 - o Led a discussion about & tour of the archives for a Trinity Lutheran Seminary I-Group
 - Provided research assistance for students in TLS's Being Lutheran in America course
 - Provided an Archives display in TLS's Hamma Library during Archives Month in October and outside Hamma Library November-December
 - Maintained the ELCA Region 6 Archives Facebook page: www.facebook.com/ELCARegion6Archives/
 - Participated in the SOA's Ohio Archives Passport: https://ohioarchivists.org/wp-content/uploads/2019/10/SOAOhioArchivesPassport2019.pdf
- Staffing: Welcomed 3 student workers and 1 volunteer
- ELCA Regional Archives Grant: The ELCA Region 6 Archives was awarded an ELCA Regional Archives Grant from the ELCA for its "Display-in-a-Box" project: 6 accordion book displays about special topics in congregational records management and archives to be circulated within the IN-KY, Northeastern OH, Northwestern OH, North/West Lower MI, Southeast MI, and Southern OH Synods. MIF provides a range of investments for individuals, congregations and ministries. We put those investments to work to fund building and renovation loans for congregations and ministries.



During the year-long pandemic, MIF provided assistance to investors who needed immediate access to their funds and to borrowers who needed flexibility with their loan payments. We collaborated with our ministry partner, the ELCA Federal Credit Union, to offer expedited loans for congregations, ministries and individuals, as well as Paycheck Protection Program loans for congregations and ministries to keep employees on the payroll and continue operations.

Our capabilities and capacity have never been stronger. At year-end 2020, MIF had 883 loans outstanding, totaling \$596.4 million. Investment obligations totaled \$543.1 million. With total assets of \$773.8 million and net assets of \$218.2 million at year-end 2020, MIF maintains a capital ratio of 28.20 percent—positioning MIF in the top tier of well-capitalized church extension funds.

Our steadfast support continues for the members, congregations and ministries of the ELCA and the many ways you care for a world in need. We are honored and humbled to walk alongside you as a trusted partner.

Greetings siblings in Christ of the North/West Lower Michigan Synod,

It has been a difficult year for all of us. Despite restrictive policy changes and the challenges of the COVID-19 pandemic, however, LIRS has remained committed to our biblical mandate to welcome the stranger.

In the last year:

- · 2,782 refugees were welcomed through LIRS affiliates in 23 states.
- 440 unaccompanied migrant children were served through our foster care services and placed in loving homes during and after legal proceedings.
- 9,500 asylum seekers received Safe Release and Post Release services at our Southern border.

Even in these darkest of days, thousands of people from across the country partnered with LIRS to express their support for migrants and refugees through our annual programs and advocacy efforts. The compassion of our neighbors gives us hope, and we are proud to report that in the last year:

- 16,000 holiday cards and 500 gifts were sent to migrant children and families in detention through our annual Hope for the Holidays program.
- More than 600 ELCA clergy and lay leaders signed a letter drafted by the ELCA and LIRS urging Congress to work collaboratively to advance comprehensive immigration legislation.
- LIRS' work was featured on national platforms like NPR, the Washington Post, Center for American Progress, Religion News Service, The Christian Century, and Sojourners.

We are especially grateful for the congregations and communities in the North/West Lower Michigan Synod who have continued their generous and prayerful support. We could not do this work without you.

Now, that work is expanding. In the coming year, the U.S. expects to welcome 125,000 refugees to our shores. LIRS is actively looking to congregations and faith leaders to partner with us in ways big and small, including donations, volunteer work, and participation in our annual programming. Emmaus:

Congregational Discernment Network launches this spring for congregations to discern how they can best walk alongside refugees and migrants in their community, and Stand Up Speak Up, coming in Pentecost, is a new interfaith prayer vigil focused on advocacy. We encourage you to stay up to date on opportunities for individual and congregational engagement at the LIRS Action Center, found at www.lirsconnect.org/get_involved

With your support, we will continue to live our mission: witnessing to God's love for all people, standing with and advocating for migrants and refugees, and transforming communities through ministries of service and justice. Section A

This section includes mandated and recommended constitutional changes from the 2019 Churchwide Assembly. Mandated changes (those preceded by the symbol †) must be adopted as is. These changes were to have been adopted by the 2020 Synod Assembly and have been carried over to 2021.

Section B

These updates are from the North/West Lower Michigan Synod Constitution Committee to bring the current synod constitution into compliance with the Model Constitution for Synods and to place bylaws and continuing resolutions where they more appropriately belong. These changes were to have been adopted by the 2020 Synod Assembly and have been brought forward to this year.

Section C

Only two (2) Continuing Resolution updates to the Synod Constitution have been made and they are presented for information to the 2021 Synod Assembly. These continuing resolutions have been adopted by the Synod Council and do not require a vote of the Synod Assembly for adoption.

RESOLUTON A

Toward a Creative, Dedicated Reduction of Disposable Plastics

Whereas, there is a growing mindfulness of the degradation of the earth with the ubiquitous presence of plastics (an estimated 86 million tons of plastic packaging produced annually), especially of single-use plastics which are not or cannot be recycled properly, polluting our oceans, waterways, and communities, negatively impacting our health as well as the health of land- and marine-based ecosystems; and

Whereas, as members of the Body of Christ, and specifically of the ELCA since the adoption in 1993 of the social statement, Caring for Creation, we have challenged each other to steadfastly care for creation with vision, hope, and justice, praying for the creativity and dedication "to live more gently with the earth"; and

Whereas, every congregation and every member of our synod can be a bearer of hope and a courageous witness to God's profound involvement with and love for this increasingly despoiled world; therefore be it

Resolved, that we, as voting members of this Synod Assembly, commit to a sustained awareness of the urgency to radically reduce our own use of disposable plastics, finding and creatively using sustainable, reusable alternatives; and be it further

Resolved, that we ask the Synod Council, our Bishop, and every rostered leader to assist us in urging our congregations to likewise adopt creative and dedicated alternative practices; and be it further

Resolved that we, as the North/West Lower Michigan Synod and as individual members and as congregations pray for the courage and fluency to publicly share our concerns and our hopes with local, national, and international businesses urging them to move quickly and rigorously in utilizing and promoting reusable and/or biodegradable products.

RESOLUTION B

Responding to the Climate Emergency

Whereas, in 1993 with the Caring for Creation¹ social statement, we, in the ELCA realized the urgency was already "widespread and serious, according to the preponderance of evidence from scientists worldwide [of] dangerous global warming, caused by the buildup of greenhouse gases, especially carbon dioxide" from the burning of fossil fuels, and that "action to counter degradation, especially within this decade, is essential to the future of our children and our children's children"; and

Whereas, the most recent report by the 2019 U.N. Intergovernmental Panel on Climate Change claims continued greenhouse gas emissions will cause "long-lasting changes in all components of the climate system, increasing the likelihood of severe, pervasive and irreversible impacts for people and ecosystems"; and

Whereas, while actions of individuals and congregations responding to the climate emergency may well serve as significant prophetic and anticipatory symbols; only bioregional, national and international regulations, policies and corporate commitments could adequately reduce the pace of climate change and lead to equitable means of adaptation; therefore be it

Resolved, that this Synod declares that the climate emergency is a spiritual and moral crisis that calls for an urgent, faith-rooted response similar to the demands for justice and mercy voiced by the Hebrew prophets, by Jesus and the New Testament writers; and be it further

Resolved, that this Synod through the office of the Bishop, the Publicly Engaged Church Table, the Environmental Stewardship Task Force and its rostered leaders be encouraged to publicly and consistently advocate for those policies, corporate practices and governmental cooperation that would slow the pace of climate change and promote equitable adaptations; and be it further

Resolved that the congregations of this Synod be encouraged to commit themselves to learning, prayer and repentance leading to faithful environmental stewardship and care for those most affected by climate change.

Treasurer's Annual Report

For Fiscal Year Ended January 31, 2021

Submitted by Daniel L Carter, Treasurer

With God's help and encouragement, the North/West Lower Michigan Synod continues to be in good financial condition. It goes without saying that 2020 was a challenging financial year. But we came through. Our recently completed audit indicates that we have again maintained our financial stewardship consistent with the prior years. For the year ended 1/31/21 our Change in Net Assets was an increase of \$244,132. Our mission support decreased by nearly \$32,000 from the prior year. This was offset by a decrease in the Synod's total Operating Expenses for the year of \$154,000. In addition, our investments performed well, and we received additional financial support from other sources. Our Auditor's Letter of Comments was consistent with the prior year and we had no material deficiencies.

We continue to share 50% of our congregations' Mission Support with ELCA Churchwide to support the ministries of our larger Church. This proportionate share totaled approximately \$654,000 which is about \$20,000 less than the prior year.

With the help of our auditor's and staff, we have once again continued to improve our financial management, oversight, and reporting system. Please review the audited financial statements. Net assets, revenues, gains and losses are classified based on the existence or absence of donor- or grantor- imposed restrictions. Note 1 includes an excellent summary of the Synod's Programs. Note 10 lists the various endowments and funds held by the Synod and whether they are subject to restrictions. Page 6 illustrates that for the last year, 86% of our resources were used to fund Program Services.

For the 2020-21 year we continued to invest in our people to meet the goals of our strategic plan for the Synod. Due to the pandemic, the Synod was unable to maintain its strategy for the Bishop and Staff to visit and meet with all congregations across the synod within a deployed model. This reduction of these activities resulted in lower expenses for the Synod. We are grateful that our congregations continued to financially support the Synod. For the 2021-2022 year and 2022-2023 year we have made additional adjustments to our annual budgets to align with anticipated reductions in mission support and reflect the realities of the current economy and pandemic. We greatly appreciate the financial support we have received during these difficult times.

The Synod continues to manage its operations in a very dynamic environment, but it is continually committed to maintaining a balanced budget.

Financial Fact Sheet

❖ As of January 31, 2021, the North/West Lower Michigan Synod held \$594,491 of its net assets in the ELCA Foundation Pooled Trust Fund A in an account named "North/West Lower Michigan Synod Endowment Fund." Unlike other endowed funds, there are no donor restrictions on these resources; Synod Council has the authority to designate and disburse them.



Other net assets held in the ELCA Foundation Pooled Trust Fund A are bound by donor restrictions. They total \$1,736,886.

- ❖ These funds saw a 10.59% increase in stock market value from February 1, 2020 to January 31, 2021.
- In addition to the Endowed Funds shown above, the synod holds 21 donor-restricted funds for special projects and programs like Disaster Relief, Staff Growth, Honduras, Multicultural Ministries, Publicly Engaged Church, and ELMM Scholarships.
- ❖ Year to date Mission Support to the synod as of March 31, 2021, is up 39% compared to the same period last year. Much of this variance is due to congregations coming through the pandemic in strong financial position with the help of SBA PPP Loans and faithful, generous giving.
- ❖ The FYE 01/31/21 Audit reports that the synod spent 86% on programming and program support and 14% on management and administration.

THE ELCA FOUNDATION

It is important to begin this report by thanking our synod bishops, congregations and partners for their incredible leadership during a year of upheaval and challenges. When everything seemed to go wrong, your ability to direct the work of the church was one of the things that was right in 2020. Through it all, this church supported the work of ministering to the world with the love of Jesus Christ. We are grateful to be church together with you.

As of Dec. 31, 2020, the Foundation has crossed a major milestone — \$1 billion in assets managed in gifts and endowments for the ministry of the greater church. This achievement reflects being the church together in ways that equip congregations, organizations and individuals to live out their vocation. This landmark accomplishment was achieved through the work of the ELCA Foundation staff regularly engaging with donors, congregations and organizations along with your trust in the ELCA Foundation to manage gifts and assets for ministry. Throughout the year, despite limited travel and in-person meetings, gift planners engaged with nearly 900 congregations, synods and ELCA-related organizations. They spent time with over 1,500 individuals working on gift plans, logged over 5,500 interactions and continued to maintain partnership relationships with over 150 ELCA-related entities, including 54 synods.

Fund A distributed over \$30 million to ministry in 2020 while also growing the underlying investment to ensure that distribution is there for years to come. Fund A has neither missed nor reduced a distribution amount once it was established – including the volatile year of 2020. We know these distributions are vital to ministry and often used to support service in local communities.

- As of Dec. 31, 2020, the value of participant accounts invested in Fund A was \$904.2 million, compared to \$817.6 million on Dec. 31, 2019. There are 1,155 investing participants in Fund A, including 938 congregations and 54 synods.
- Throughout the year, 53 new endowment accounts were opened, totaling \$7.1 million, and 14 accounts were closed, totaling \$3.0 million. Investments made to new and existing Fund A accounts totaled \$31.1 million; withdrawals totaled \$18.6 million.

In addition, gift levels remained high throughout 2020: Due to the generosity of our members and donors distributions to ministry totaled \$59 million for the year.

- The gift-planning network, including affiliates, posted solid results throughout 2020, with \$118.2 million in total gifts and endowment assets. Of that, \$78.5 million was written in future planned gifts, \$20.3 million in current gifts (including funded trusts, gift annuities and individual endowments) and \$19.4 million in new assets invested in Fund A.
- New gift plans written during the year totaled 249. In addition, gift planners stewarded over \$60.2 million in previously written plans, in some cases increasing the estimated gift to ministry.

The Foundation exists as a separately incorporated ministry, with a network of 23 regional gift planners, working in 21 partnerships, across the United States. Critical to their work and ministry funding outcomes are the Gift Administration and Financial Services (accounting and investment administration) teams. These teams are the bench strength of the deployed gift planners, providing continuous assistance to donors, beneficiaries and Fund A investors — all this despite limited access to the building due to the pandemic.

The Foundation staff continues to work with donors and beneficiaries to create individual gift plans, administer life income and endowment gifts, distribute terminated gifts and facilitate the sale of marketable assets such as land, homes, commodities and other assets.

- · Regional gift planners remain available to:
 - Guide individuals in discerning how to be faithful stewards of their estates and invite them to support ministries, congregations and synods through charitable estate gifts.
 - Assist synods, congregations and related entities in investing endowment funds and
 other assets in the Endowment Fund Pooled Trust Fund A, which is structured to
 provide distributions to support ministry today and into the future, utilizing investments
 that adhere to the ELCA's social purpose guidelines.
 - Advise church leaders in the development of gift acceptance policies for congregations, which often include gifts to synods.
