## **Presiding Bishop**

Bylaw 19.01.02. specifies the process for nomination and election of the presiding bishop, as follows:

The presiding bishop shall be elected by the Churchwide Assembly by ecclesiastical ballot. Three-fourths of the votes cast shall be necessary for election on the first ballot. If no one is elected, the first ballot shall be considered the nominating ballot. Three-fourths of the votes cast on the second ballot shall be necessary for election. The third ballot shall be limited to the seven persons (plus ties) who received the greatest number of votes on the second ballot, and two-thirds of the votes cast shall be necessary for election. The fourth ballot shall be limited to the three persons (plus ties) who receive the greatest number of votes on the third ballot, and 60 percent of the votes cast shall be necessary for election. On subsequent ballots, a majority of the votes cast shall be necessary for election. These ballots shall be limited to the two persons (plus ties) who receive the greatest number of votes on the previous ballot.

## **Secretary**

Constitutional bylaw 19.01.04. specifies the process for nomination and election of the secretary, as follows:


The secretary shall be elected by the Churchwide Assembly by ecclesiastical ballot. The election shall proceed without oral nominations. If the first ballot for secretary does not result in an election, it shall be considered a nominating ballot. On the first ballot, three-fourths of the votes cast shall be required for election. Thereafter only such votes as are cast for persons who received votes on the first or nominating ballot shall be valid. On the second ballot, three-fourths of the votes cast shall be required for election. On the third ballot, the voting shall be limited to the seven persons (plus ties) receiving the greatest number of votes on the second ballot and two-thirds of the votes cast shall be necessary for election. On the fourth ballot, voting shall be limited to the three persons (plus ties) receiving the greatest number of votes on the previous ballot and 60 percent of the votes cast shall elect. On subsequent ballots, voting shall be limited to the two persons (plus ties) receiving the greatest number of votes on the previous ballot and a majority of the votes cast shall elect.



A voting member who desires to offer an amendment or a substitute to a recommendation of the Memorials Committee must submit the memorials form electronically or as a paper form. The text of the proposed amendment or substitute also must be submitted on the motion form electronically or on a paper form to the secretary or the secretary's deputy. Copies of the paper motion form may be requested from the secretary's deputy. Amendments and substitute recommendations must be submitted to the secretary of this church or the secretary's deputy no later than 9:45 p.m., Monday, August 5, 2019, as established in the Rules of Organization and Procedure for this assembly.

Consultation with at least one of the co-chairs of the Memorials Committee is *required* when a substitute to the response recommended by the Memorials Committee will be proposed. Consultation with one of the co-chairs is *recommended* when proposing an amendment.

Deadline to offer an amendment or a substitute to a recommendation must be submitted no later than 9:45 PM on Monday, 8/5/19.

Consultation with at least one co-chair is required.

# Rationale for Amendments to Constitution, Bylaws and Continuing Resolutions of the ELCA Constitution

## **Preparation Suggestions**

- Review the linked documents
  - Many of these amendments are "housekeeping" amendments.
  - We are removing the term ELCA as a modifier.
  - We have replaced the word "partner" or "partnership" with words we hope give a better description of the relationships.
  - The entrance rite for ministers of Word and Service and their status in the "representational principle" of this church has been studied by the "Entrance Rite Discernment Working Group." Their recommendations are incorporated in the establishment of ordination as the entrance rite for this roster. They also recommended that ministers of Word and Service would not be counted as laypersons when implementing the "representational principle" of this church.

## "A Declaration of Inter-Religious Commitment: A Policy Statement of the ELCA"

## **Preparation Suggestions**

- Review the Proposed Policy Statement
  - The 1989 Churchwide Assembly adopted [CA89.3.15] "Ecumenism: The Vision of the ELCA" as a working document. The 1991 Churchwide Assembly adopted [CA91.3.7] its second part, "A Declaration of Ecumenical Commitment: A Policy Statement of the ELCA", as the policy of this church.
  - Presiding Bishop Elizabeth A. Eaton appointed an ELCA Inter-Religious Task Force in 2016 for the purpose of developing an official statement to describe this church's commitments and aspirations in its interfaith work. The task force produced a draft policy statement and conducted a review and comment period during the first six months of 2018.
  - The task force incorporated recommendations it received about the draft into this proposed policy statement.
